I understand that this trip and going abroad carries an inherent risk of physical injury and safety concerns. I certify that I am in good health and physically able to be a member of this team. I understand that I am engaging in this mission at my own risk and assume all responsibilities including related costs and expenses for any injury incurred to myself or to my property while on this trip.

I understand that I am fully responsible and liable for my personal effects and property. I agree to indemnify and hold Grace Church North County Oceanside, their officers, employees, and volunteers harmless from all liability and suits for personal injury, sickness, death, property damage and/or loss of any nature. I further understand that I am personally responsible to abide by the instructions of the mission coordinator for duration this mission trip.

I have been given a review of potential health hazards and recommendations for vaccinations. I am herein informed of the website: www.cdc.gov to check for any additional vaccination and travel advisories for (country) . I (or parent, if a minor) am solely responsible for procuring vaccinations for myself on a timely schedule for this trip. I understand that in the event of a medical emergency that my Mission Team will act as the authority to make decisions for me if they cannot get in contact with my emergency contact as noted on my Health Information Form. The team will expedite any necessary and life saving medical care to the best of their knowledge in any circumstance that arises where I am in need of medical attention. I hold the team blameless for any medical decisions made on my behalf, in the event of a medical emergency, when done with due diligence and consideration of available information. If I am a minor my legal guardian has signed below and acknowledges and agrees with the content of this document.

I will conduct myself in a proper manner, as a Christ follower, as an American citizen, and as a guest of (country) I will not engage in any unbecoming behavior or speech that may endanger myself or the team, and will abide by the laws of (country) to the best of my knowledge. I will follow the direction of Team Leaders.

I will refrain from the consumption of alcohol, cigarettes, tobacco, and the use of any illegal substances as a participant on the mission trip from start to finish including in transit, and I will not carry any weapons or contraband into or out of (country).
